


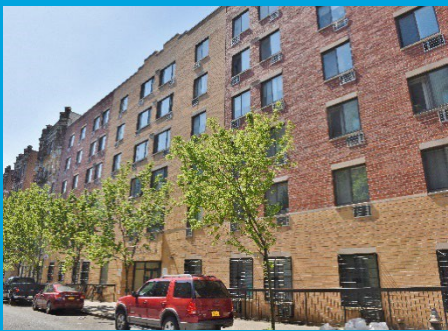

The New York Land Opportunity Program (NYLOP) seeks and supports faith-based organizations (FBOs) to develop affordable housing units throughout the five boroughs bridging the gap between aspiration and achievement.

Program Goals

LISC NY established this program to support mission-driven organizations (MDOs) or faith-based institutions (FBOs) interested in using their real estate to develop affordable housing for New York City residents. The vision is to assist FBOs/MDOs use their property to develop much-needed affordable housing. NYLOP has a goal of developing at least 180 affordable housing units in its premiere cohort.

Program Components

LISC NY will provide technical assistance to the selected MDOs or FBOs through a team of technical experts, including development consultants and architects, to provide one-on-one technical assistance and create development concepts with buy-in from each MDO or FBO. In addition, an attorney will help to ensure that MDOs or FBOs understand the different types of partnerships they may form with their chosen developer.

Program Requirements

Applicants must meet the following minimum qualifications to be considered for participation in the NYLOP:

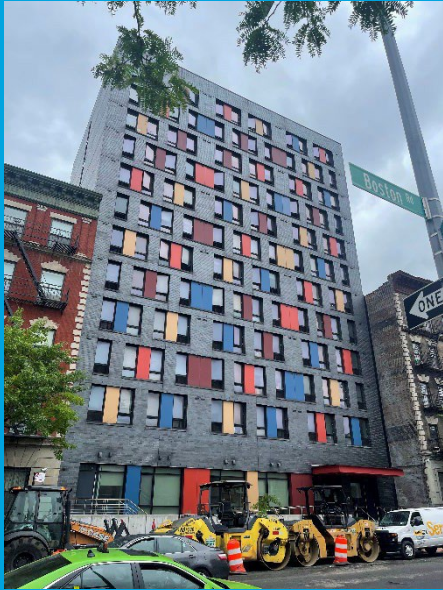
1. Be incorporated as a non-profit corporation
2. Have ownership or long-term leasehold for vacant or underutilized property suitable for housing.
3. Have a track record of providing services to their community.

Program Participants
