(3) Conditions of establishment.—

2  $(\mathbf{A})$ DETERMINATION BY THE SEC-3 **RETARY.**—The National Historical Park shall 4 not be established until the date on which the 5 Secretary determines that a sufficient quantity 6 of land or interests in land has been acquired 7 from land identified as "Proposed Boundary" 8 on the map to constitute a manageable park 9 unit.

10 (B) NOTICE.—Not later than 30 days
11 after the date on which the Secretary makes a
12 determination under subparagraph (A), the
13 Secretary shall publish in the Federal Register
14 notice of the establishment of the National His15 torical Park.

16 (4) MAP.—The map shall be on file and avail17 able for public inspection in the appropriate offices
18 of the National Park Service.

19 (5) BOUNDARY.—The boundary of the National
20 Historical Park shall include any land or interests in
21 land acquired by the Secretary under this section.

22 (b) Administration.—

(1) IN GENERAL.—The Secretary shall administer the National Historical Park in accordance
with—

1	(A) this section; and
2	(B) the laws generally applicable to units
3	of the National Park System, including—
4	(i) sections 100101(a), 100751(a),
5	100752, 100753, and 102101 of title 54,
6	United States Code; and
7	(ii) chapters 1003 and 3201 of title
8	54, United States Code.
9	(2) Agreements.—
10	(A) Cooperative agreements.—In ac-
11	cordance with section 101702 of title 54,
12	United States Code, the Secretary may enter
13	into cooperative agreements with the State or
14	other public and private entities to provide in-
15	terpretive and educational services within the
16	National Historical Park.
17	(B) INTERPRETATION AND RESTORATION
18	AGREEMENTS.—The Secretary may enter into
19	agreements to identify, interpret, and restore
20	nationally significant historic or cultural re-
21	sources located on non-Federal land within the
22	boundary of, or in close proximity to, the Na-
23	tional Historical Park.
24	(C) PUBLIC ACCESS.—Any cooperative
25	agreement entered into under subparagraph (B)

1	to provide assistance to non-Federal land shall
2	provide for reasonable public access to the non-
3	Federal land.
4	(3) Acquisition of Land.—
5	(A) IN GENERAL.—Subject to subpara-
6	graph (B), the Secretary may acquire land and
7	interests in land located within the boundary of
8	the National Historical Park by—
9	(i) donation;
10	(ii) purchase with donated or appro-
11	priated funds; or
12	(iii) exchange.
13	(B) LIMITATION.—Any land owned by the
14	State or a political subdivision of the State may
15	be acquired for inclusion in the National His-
16	torical Park only by donation.
17	(4) MANAGEMENT PLAN.—Not later than 3 fis-
18	cal years after the date on which funds are made
19	available to carry out this section, the Secretary, in
20	consultation with the State, shall complete a general
21	management plan for the National Historical Park
22	in accordance with—
23	(A) section 100502 of title 54, United
24	States Code; and
25	(B) any other applicable laws.
